## Preface

Persons working in health care and other selected professions are increasingly confronted with difficult and complex HIV/AIDS issues. Knowledge of the disease and up-to-date information on legal and patient care issues are vital.

In response to this need for up-to-date information, the Florida Legislature mandated broad HIV/AIDS education requirements for the health care industry. According to Florida Statutes, specific health care professionals are required to have HIV/AIDS education as a condition of initial licensure and/or biennial relicensure. The individual licensing boards establish the hourly requirement and specific course requirements.

The legislature also requires licensed health care facilities to educate their work force on HIV/AIDS as a condition of licensure and biennial relicensure. The individual licensing unit also establishes these specific requirements.

Bureau of HIV/AIDS staff have compiled the following information to clarify HIV/AIDS education requirements for the health care industry, as well as to provide a contact for further questions.

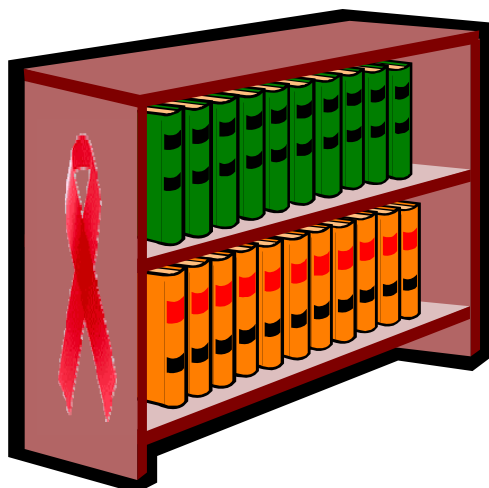
